House bill 4420 at Mass state house. Most restrictive gun bill in U.S.

Bans hunting on private property. Bans any under 15 to receive training for shooting sports. All guns need to be serialized. All modification to firearms requires permission from police.

Nobody under 21 can possess anything semiautomatic. Dealers can't transfer handguns if they are not smart guns. Restriction on common carriers can't transport guns unless have special.

State police not in favor of this. Enforcement would fall to state police only.

141 pages in this law. Jim will send email with excerpts from the law and link to the bill. This is planned to pass.

Want to eliminate hunting and want to eliminate gun ownership. Everybody needs to contact their legislators.
